#### **Master Degree in Barranquilla**



The new Master's Degree on Communication, with emphasis in culture and social change, is finally off the ground by the end of March 2007 at the Universidad del Norte in Barranquilla, Colombia.

The Communication for Social Change Consortium is supporting the Masters in Communication with seed funds for research projects, exchanges of international faculty and partial scholarships for Latin American students that are willing to travel to Colombia to take the Masters degree. The amount of each scholarship is US \$4,000 dollars, which covers most of the cost of tuition.

The objective of the Masters degree, which focuses on Communication, Culture and Social Change, plans to prepare strong researchers who will generate theoretical and applied research, aiming to find, through communication, solutions to the problems that the region faces.

The research programme of the master's degree covers three areas: Communication, Citizenship and Social participation; Communication, Cities and Local development; and Communication and Health. The master's degree will gather faculty from Colombia and visiting professors. Among them: Mario Mosquera, Jair Vega, Rafael Obregon, Pamela Flores, Clemencia Rodriguez, and Thomas Tufte.

Those students from Latin American countries that have limited resources and a good background in development programmes may apply for the partial scholarships.

OurMedia 6th Conference (OM6) next April 13-19, aims at building strategies and collaborations among academics, non-governmental organizations, practitioners, artists and advocates for the promotion of communication rights, effective access to ICT, community and citizen participation in the media and community engagements that foster social change, women's participation in the sector and cultural revitalization.

The Communication for Social Change Consortium, represented by Alfonso Gumucio-Dagron, will be facilitating along with Jethro Pettit from IDS (Sussex), Stream 2 on "Communication and Social Change".

The conference general theme aims to explore the cultural and social significance of independent community and alternative media and the major challenges in the decades lying ahead. In this regard, OM6 positions itself as a unique event that bridges the work being done by action researchers, engaged academics, community practitioners and artists in order to promote and defend the spaces of alternative media for social justice, equality and inclusion as factors of social change and cultural development.

The OM6 Conference Organizing Committee received close to 200 proposals, from over 35 countries, including academics, activists, community media practitioners, artists, media and social researchers. Participants will represent over 60 universities and research centers worldwide (including 11 from Australia) and over 50 community media organizations, NGO's and alternative media/arts collectives.

The OM6 Conference is bringing together international and national experts, researchers, policy makers, activists and local community development practitioners to discuss ways to ensure a sustainable future for building participatory community, alternative and citizen's media. The conference is hosted by the <u>School of Communication Arts</u>, University of Western Sydney in association with the <u>Centre for Cultural Research</u> at UWS, and the <u>Faculty of Humanities and</u> <u>Social Sciences</u>, University of Technology, Sydney. Our community partner organization is <u>Information and Cultural Exchange (ICE)</u>, an organization based in Granville, Sydney.

In the medium term, she is also looking at strengthening the master degree.

### **New Network of Intercultural Universities**

Twenty-five universities of Latin America decided to create the Latin-American Network of Intercultural, Indigenous and Bi-lingual Universities, with the objective of promoting intercultural studies and to contribute to democracy by facilitating a dialogue with indigenous people. This is the foremost result of a recent meeting of universities and seminar of experts that took place in Tepoztlán, Morelos (Mexico), on 12-14 March 2007.



The creation of the network responds to various lines of action that were identified, among which the increasing demand of higher education from indigenous people, and the need to create and strengthen the existing programmes and projects of bilingual and intercultural education.
